### Trial Information

1. All entrants must produce their current GSSCC membership card.
2. A photocopy of the dog's registration certificate or pedigree must be presented with the scorebook on all German Shepherd Dogs entered in the trial. This must be presented to the trial secretary prior to the handlers' meeting.
3. Females in season can be entered but will be judged last. They will not be allowed on the trial field prior to their competition time.

**Breed Survey** 9:00 am

**Show** To follow breed survey starting with female baby puppy class, alternating to male baby puppy class, etc.

- No inter-class or inter-sex judging
- All classes over 12 months will be subject to a gun test
- No spayed or neutered dogs can be shown
- Dogs entered in working class must have a minimum of a SchH I degree

Trophies will be presented to 1<sup>st</sup> place in all (non baby puppy) classes.  
Rosettes will be presented to 1<sup>st</sup>-4<sup>th</sup> place in all (non baby puppy) classes.

**General Information**

1. All cheques for entries are to be made payable to the German Shepherd Dog Club of Edmonton. No post-dated cheques will be accepted. In the case of NSF cheque, an additional charge of \$20.00 will be levied to cover expenses. Non-compliance will mean entry will not be accepted.
2. All events will take place at our clubhouse grounds (tracking fields will be posted). See map for directions to club.
3. Meals, snacks and refreshments will be available throughout the weekend.
4. All dogs must be under control and on leash when on club grounds. Special areas will be set aside to enable handlers to exercise and run their dogs.

## Show Information

1. Only registered German Shepherd Dogs will be allowed in the show.
2. In the event that no dog(s) receive(s) the highest available rating in their respective class (over 12 months) no trophy will be given out. Rating trophies will only be given out where merited by the judge.
3. All classes over one year will be subjected to a gun test.
4. Adult dogs without a minimum SchH 1 must be entered in the Adult (Open) Classes (24+ months without a SchH title).
5. Dogs in the Working classes must provide proof of a minimum SchH 1.
6. All Working Class participants must be members in good standing of the GSSCC or a WUSV affiliate clubs and must present a valid membership card.
7. Photocopies of documentation must accompany entries.
8. All original documentation must be submitted at the registration desk prior to the event.
9. Females in heat may be presented, but the show secretary must be notified in advance.
10. No surgically altered dogs are permitted.

## Breed Survey

1. All participants must be members in good standing of the GSSCC or a WUSV affiliate clubs and must present a valid membership card.
2. Dogs must:
  - a. Be at least two (2) years of age during 2009
  - b. Have certified hips (OVC, OFA, 'a' stamp)
  - c. Have a minimum SchH 1 under VDH rules
  - d. Have an AD (endurance test) under VDH rules
  - e. Have a minimum 'G' show rating under SV rules.
3. Photocopies of documentation must accompany entries.
4. All original documentation must be submitted at the registration desk prior to the event. This must include:
  - a. Registration Certificate
  - b. Three generation official pedigree
  - c. Hip Certification
  - d. Proof of BH, AD, Schutzhund Title(s) (scorebook) from SV, USA or GSSCC judge
  - e. Proof of show rating
  - f. If the dog is being re-surveyed, the original survey certificate must also be submitted
5. Females in heat may be presented, but the show secretary must be notified in advance.

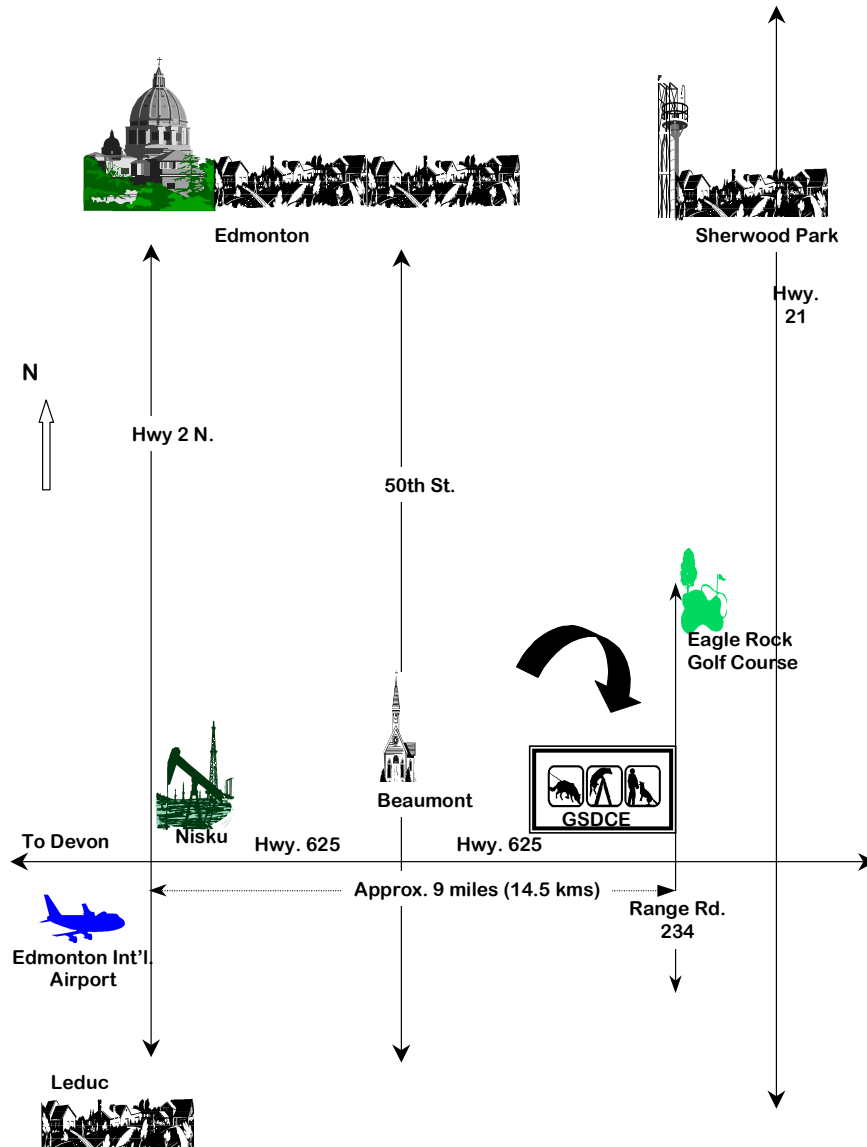
